Who Must File:

Each employer within East Canton Village limits who employs one or more persons is required to withhold the tax of one and one half percent (1.5%) from all compensation paid taxable employees at the time such compensation is paid, and to file Form EQR and remit tax to the Village Income Tax Dept. on or before the 15th day of the month next following the MONTHLY period in which the withholding deduction was made.

Who Must Pay:

All persons must pay village income tax as it may apply in accordance with village ordinances.

Failure to File Return and Pay Tax:

Any taxpayer who shall fail or refuse to make any return or declaration required by the Ordinance, or any taxpayer who shall refuse to pay the tax imposed by the Ordinance, or any taxpayer who shall refuse to permit the administrator to examine his books, or who shall knowingly make any incomplete, false of fraudulent return, or who shall attempt to avoid the payment of tax, shall be guilty of a 1st degree misdemeanor and shall be fined not more than \$1,000.00 or imprisoned for not more

than six (6) months, or both. The failure of any taxpayer to receive a return or declaration form shall not excuse him from making a return or declaration or from paying the tax.

If receipt is desired, return Taxpayer's Copy of this form and enclose self-addressed, stamped envelope.

How to prepare this Form:

- Line 1 Enter total compensations PAID all taxable employees during the quarter for which return is made. If no compensation was paid during the month, so indicate and return Form.
- Line 2 Enter total ACTUAL tax withheld from taxable employees during the month for East Canton, Ohio Income Tax.
- Line 3 To Adjust current payment of actual tax withheld for underpayment or overpayment in previous month.
